A workshop was organised by Internal Complaints Committee for Women (ICC) and Internal Quality Assurance Cell (IQAC) of Shri Guru Buddhiswami Mahavidyalaya, Purna on 'Legal Advice' on 14<sup>th</sup> February, 2019 at 10.30 am in the ICT hall for the degree students. Ad. Madhuri Kshirsagar, a renowned advocate from Parbhani, was the resource person for the workshop. She educated the students, specially, girl students about various laws and rules meant for the women protection. She gave detailed information to the participants about POSCO, child abuse prevention act, the Child marriage prevention act and various other laws that for protection of women from harassment, sexual abuse, etc at working places and public places.

The programme was organised under the guidance of Principal Dr. K. Rajkumar. Smt. T.A. Shaikh, Chairman, ICC was the president of the programme. Dr. Adinath Ingole, Vice Principal gave the introduction of the programme. Smt. T.A.
